For year 2013, Annual Membership Fee Is \$30.00. Fees for new members joining after 1 July, are \$15.00. All memberships expire on December 31. Your right to the field and to fly at the field also expires. You must renew your membership by December 31, if you plan to fly the next year. All members must complete a new application each year and show proof of updated AMA Membership. Faxes from AMA must have your AMA number affixed.

Meetings are usually held the first Monday of each month, 7 PM, and in May, June, July, August, and September at the flying field. Meeting places and dates may vary for unforeseen reasons. Members will be informed by newsletter, email, or verbally of changes.

New fliers must have aircraft inspected and be assisted by a qualified flier until soloed.

### **Everyone must read and sign:**

I hereby agree to comply with all the AMA SAFETY CODES, Shawnee Thunderbird RC Club Safety Rules and Field Rules for all model aircraft operations at all Shawnee Thunderbird Club Flying Sites. I further agree to abide by and comply with the Shawnee Thunderbird RC Club Bylaws and to any changes or modifications that may be made to the rules and/or bylaws during my membership period. I understand and agree that as a condition of membership, my failure to comply with all applicable SAFETY and FLYING RULES, and/or failure to conduct myself in a gentlemanly/lady like manner will result in the revoking of my membership. I understand and agree to provide the AMA and a Shawnee Thunderbird RC Club Officer written notice within thirty (30) days of an occurrence of any incident of bodily injury and/or property damage.
